**Elron Announces Purchase of 323,513 Additional Shares of Given Imaging Ltd. for
approximately \$9.9 million**

Tel Aviv, November 8, 2004 – Elron Electronic Industries Ltd. (NASDAQ: ELRN) announced today that it has purchased from November 5, 2004 to November 8, 2004 in the open market on the Nasdaq National Market in the United States and on the Tel Aviv Stock Exchange, 323,513 additional Ordinary Shares of Given Imaging Ltd. (Nasdaq: GIVN), for an aggregate purchase consideration of approximately \$9.9 million.

As a result of these transactions, Elron's direct and indirect ownership interest in Given Imaging (through its holdings in its subsidiary, RDC-Rafael Development Corporation Ltd.) increased from approximately 18.6% to approximately 19.8%.

Elron Electronic Industries Ltd. is a multinational high technology holding company based in Israel.
